The Chamber of Commerce is asking the help of every Civic Club, Church, Citizen and School in selecting the recipients. We will honor individuals and businesses in recognition for their service to the St. Clair community.

#### Nomination Guidelines

1. Nominations should be submitted confidentially without advance publicity or petitions used to promote nominations.
2. Nominees do not need to be residents of St. Clair; however their qualifying accomplishments should have clearly benefited the City of St. Clair or its citizens.
3. Nominees can be a man or woman; however they must be alive as these awards are not given posthumously.
5. Nominations are not carried forward from year to year. If you have previously submitted a candidate who was not selected, please update that information and re-submit it.
6. Nominations should be submitted in a sealed envelope to the Chamber Office no later than January 20, 2012. The outside of the envelope should be clearly marked with the Award Category for which the nomination is being made.
7. Nominations are to be made only on the form supplied by the Chamber of Commerce. Additional forms will be supplied upon request.

### Award Categories

#### **\*\*St. Clair Spiritual Leader of the Year**

In recognition for community service **through spiritual leadership.**

Nominees do not need to be ordained ministers; however the qualifying accomplishments should have contributed to the spiritual well being of the citizens of the St. Clair community.

#### **St. Clair Youth Mentoring Award**

In recognition of a distinguished record of **mentoring of young people** in our community.

Qualifying accomplishments must have clearly benefited the young people of the St. Clair community.

#### **St. Clair Outstanding Youth Award**

In recognition for his or her **community service, academic achievement and leadership skills.**

Qualifying nominees must be 21 years old or younger and attend any **St. Clair area school.**

#### **\*\*St. Clair Citizen of the Year**

In recognition of a **unique and distinguished record** of community service.

Qualifying accomplishments should have clearly benefited the St. Clair community.

#### **Educator of the Year**

In recognition of **excellence in teaching** and contribution to the spirit of lifelong learning.

#### **Outstanding Public Service Award**

In recognition of an individual who **provides outstanding service** to the community through their job related duties.

#### **Volunteer of the Year**

In recognition of **an individual who gives of him or herself freely** in support of the goals of the St. Clair Community. We suggest nominees be submitted for volunteer deeds other than job-related duties.

#### **Business of the Year**

In recognition of **outstanding dedication and support of the St. Clair Chamber & St. Clair community** or significant business achievement during the previous year.

\*\* A committee of past recipients reviews all nominations for the specific Award Category.
